



Free tax preparation and e-filing offered by Master of Coin.

- Prepare your own tax return using TaxSlayer software on your computer at home You will need basic computer skills and all your tax documents. Don't worry if you forgot a document as you can complete your tax return later at any other computer.
- **To create your account, you will need access to you email or to your cell phone to receive a verification code.**
- We recommend using "Guide Me" mode unless you have experience in preparing taxes.
- IRS – certified VITA volunteers are here to assist you with basic tax law questions.
- To electronically file your tax return, **you will need your prior year's Adjusted Gross Income (AGI)** found on your last year's tax return.
- This tax software is also available in Spanish. Simply click on "[En Español](#)" on the top of the main TaxSlayer page (see the screenshot below).

4. Success you have created your account. You will receive a confirmation e-mail verifying that you have created an account.

5. Start your tax preparation.

We recommend using “**Guide Me**” mode unless you have experience in preparing taxes. In this mode, you will be asked series of questions to make sure you enter your information correctly.

6. **Input all your tax documents.** If you're not sure about a form, ask one of our volunteers for assistance. You will have an opportunity to review your information prior to submitting your tax return.

7. The TaxSlayer software will ask you for your **prior year's Adjusted Gross Income (AGI)**.

The AGI must match the one in IRS' record. If you did not file a tax return last year, enter your prior year's AGI as \$0.

You will be asked to create a **5-digit PIN** which will help you access your return next year.

8. E- file your tax return.

You will receive an e-mail from TaxSlayer within two to three days telling you if your return was accepted and providing further instructions if it was not.

If you don't receive an email after three days, log back into TaxSlayer's website using the information above and check the status of your return.

Finishing your tax return and e-file at home:

If you were unable to complete your return at the VITA site, you may finish your return elsewhere by going to www.TaxSlayer.com. Use the same login information that you created at the VITA site.

Your tax return filing will still be free but only if you've created an account and started your tax return at one of the City of Phoenix VITA sites. You can always come back to the VITA site if you have any questions prior to e-filing your tax return.
